

DELL DEALS CAMPAIGN PROMOTION OFFICIAL RULES

This Promotion is intended for viewing and participation in the fifty (50) United States and Washington, D.C. only and shall be construed and evaluated according to the laws of the United States. Please do not participate if you are not a legal resident of, and not located in, the fifty (50) United States/Washington, D.C. at time of entry. VOID OUTSIDE OF THE FIFTY (50) UNITED STATES AND WASHINGTON, D.C. AND WHERE PROHIBITED BY LAW.

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING.

1. **PROMOTION PERIOD:** The Dell Deals Campaign Promotion (the “Promotion”) starts June 2, 2025 at 9:00:00 AM Central Time (“CT”) and ends June 18, 2025 at 11:59:59 PM CT (the “Promotion Period”).
2. **ELIGIBILITY:** To enter and be eligible to win a prize, you must be a legal United States resident residing in the fifty (50) United States or Washington, D.C. who is eighteen (18) years of age or older, has a valid email address, and is a member of the free Dell Rewards Program (the “Program”) at the time of entry. Membership in the Program is subject to the Dell Rewards Program Terms available at <https://www.dell.com/en-us/lp/dell-rewards#Terms-%26-Conditions>. Persons in any of the following categories are NOT eligible to participate or win a prize: (a) any person who is a director, officer, agent, representative, or employee of Dell Marketing L.P. (“Sponsor”) or its parent, affiliates, subsidiaries, or service agencies, who are directly involved in the planning or execution of the Promotion; (b) any other individuals engaged in the development, production or distribution of materials for the Promotion or engaged in the administration or execution of this Promotion (collectively, with the entities listed in 2(a), the “Promotion Entities”); (c) persons who are or purport to be immediate family members (defined as biological or step-mother/ father, sister, brother, daughter, son, dependent or spouse of any of the foregoing) of any person in any of the preceding categories, regardless of where they live, or who reside in the same household as any person in any of the preceding categories; and (d) persons who Sponsor is prohibited from allowing to participate in the Program under applicable law. Promotion is subject to all applicable federal, county, and local laws and regulations.

3. HOW IT WORKS:

During the Promotion Period, go to <https://www.dell.com/en-us/shop/deals> (the “Website”), locate the link to the Promotion, complete the registration form in its entirety, verify that you have read, understand and agree to the Official Rules and submit. Once you have submitted your registration, you will be informed immediately if you have won an “Instant Win Prize” (as defined below), subject to verification of eligibility and receive one (1) entry into the random drawing for the “Grand Prize” (as defined below).

Limit one (1) game play/entry per person per day. For purposes of these Official Rules, a ‘day’ is defined as any twenty-four (24) hour period during the Promotion Period beginning at 12:00:01 a.m. CT and ending twenty-four (24) hours later at 11:59:59 p.m. CT.

Multiple entrants are not permitted to share the same email address or Dell Rewards Account. Any attempt by any entrant to use multiple/different email addresses, identities, registrations and logins, Dell Rewards Accounts, or any other methods will void that entrant's entries and entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. In the event of disqualification, any prize that entrant might have been otherwise entitled to will not be awarded.

In the event of a dispute regarding the identity of an entrant, the entry will be deemed to have been made by the authorized account holder of the email address submitted with the Program registration.

Authorized account holder is defined as the natural person who is assigned to an email address by an Internet access or online service provider, or other organization responsible for assigning email addresses for the domain associated with the registered email address. Each entrant may be required to show proof of being an authorized account holder. Sponsor's computer, or that of its designee, will serve as the official timepiece for the Promotion.

MESSAGE AND DATA RATES MAY APPLY to the use of a mobile device to participate in the Promotion. Internet access is not available on all mobile devices or available or free to use in all locations. Entrant's carrier's standard message and data rates may apply. Sponsor will not be liable for any delays in the receipt of any data as delivery is subject to effective transmission from entrant's network provider. Data obtained by Sponsor in connection with text message entries may include entrant's cell phone number, carrier's name, and date, time and content of message. Such information may be used by Sponsor to contact entrant.

4. WINNER DETERMINATION, AVAILABLE PRIZES, AND ODDS OF WINNING:

- a. **INSTANT WIN GAME:** Winning times for each available Instant Win Prize will be randomly generated throughout the Promotion Period. If you are the first eligible entrant to submit a registration form at or after one of the randomly generated times, you will be the instant winner of the prize indicated, subject to verification of eligibility and compliance with these Official Rules.

Odds of winning an Instant Win Prize depend on whether your entry submission occurs at or immediately after one of the randomly generated winning dates/times.

If due to technical, production or other errors, more Instant Win Prizes are claimed than intended, the intended Instant Win Prize will be awarded in a random drawing from all those submitting purportedly valid claims. No more than the number of Instant Win Prize set forth in these Official Rules will be awarded. ALL POTENTIAL WINNING PLAYS ARE SUBJECT TO VERIFICATION BY SPONSOR, WHOSE DECISIONS ARE FINAL AND BINDING. A "SCREEN SHOT" IS NOT PROOF OR EVIDENCE OF A WINNING PLAY AND/OR INSTANT WIN PRIZE. The following prizes are available:

UNCLAIMED/UNREDEEMED PRIZES WILL NOT BE AWARDED

Instant Win Prizes: Sixty thousand (60,000) Instant Win Prizes are available. Each Instant Win Prize consists of \$25 in Dell Rewards awarded as 2500 points deposited into the winner's Dell Rewards Program account. Dell Rewards points have no cash value (and cannot be redeemed for cash) but may be collected and redeemed in accordance with the Program terms as amended from time to time.

Entrant is eligible to win a maximum of one (1) Instant Win Prize during the Promotion Period.

- b. **GRAND PRIZE DRAWING:** At the end of the Promotion Period, one (1) potential Grand Prize winner will be randomly selected from all eligible entries received in accordance with the entry deadlines stated herein. The potential Grand Prize winner will be notified by telephone and/or e-mail, using contact information provided or collected at the time of entry. Sponsor shall have no liability for any winner notification that is lost, intercepted or not received by a potential winner for any reason. If, despite reasonable efforts, a potential winner does not respond within seventy-two (72) hours of the first notification attempt, or if the Grand Prize or Grand Prize notification is returned as unclaimed or undeliverable to such potential winner, such potential winner will forfeit their Grand Prize and an alternate winner may be selected. Sponsor, in its sole discretion, will attempt to contact up to three (3) potential winners of the Grand Prize in accordance with the above procedure, after which the Grand Prize may go unawarded if it remains unclaimed. If any potential Grand Prize winner is found to be ineligible, or if they have not complied with these Official Rules or decline the Grand Prize for any reason prior to award, such potential Grand Prize winner will be disqualified and an alternate Grand Prize winner may be selected. The odds of winning depend on the number of eligible entries received.

Sponsor may require winner and their guest to provide proof of a valid Passport prior to ticketing. Must be legally able to travel to Germany and attend IEM Cologne (i.e., no travel restrictions or visa issues).**

Option #2: An Exhibitor Sponsorship at Dell Tech World 2026 in Las Vegas, NV for winner and up to three (3) guests. Prize includes: a) round-trip economy class airfare from a major airport near winner's residence to Las Vegas, NV (airports selected at the sole discretion of Sponsor); b) up to four (4) nights hotel accommodations (four (4) rooms); c) an Exhibitor Sponsorship Package including a Pre-event, business logo on

sponsors page, a pre-event promotional kit, on-site promotion, mobile app inclusion: logo, 100-word company description, company URL and booth number, expo and meeting space, solutions Expo space (10'x10'), three (3) booth staff passes, and one (1) full conference pass (Exhibitor Sponsorship Package awarded as part of the prize ONLY if winner is associated with a qualified and relevant business as determined by representatives of Sponsor – Sponsor will work with any winner who chooses this prize option to determine relevancy), and d) a Precision Mobile Workstation, Model: 3591, or comparable laptop valued up to \$1,500 retail value. The ARV of Option #2 is \$28,250.

Option #3: A \$20,000 Dell Shopping Spree Prize will be awarded in the form of 200,000 Dell Rewards points. These points will expire on the 15th day of the 4th month following the award date. The points can be redeemed over multiple transactions and can be used on dell.com or directly through an assigned Dell technical advisor. The winner can select from any qualifying product under the Dell Rewards program terms. A Dell technical advisor will be available to assist the winner throughout the redemption process. The ARV of Option #3 is \$20,000.

Travel must be taken on dates designated by Sponsor. Dates of departure and return are subject to change at Sponsor's sole discretion. Winner's guest(s) must be eighteen (18) years of age or older and must sign and return a Liability/Publicity Release prior to ticketing of the prize. Winner and their guest must travel together on the same itinerary and possess all required travel documents, including valid photo ID. Air transportation tickets are non-refundable/non-transferable and may not be valid for upgrades and/or frequent flyer miles. The Promotion Entities shall not be responsible for any cancellations, delays, diversions, substitutions, or any other act or omissions whatsoever by air carriers, hotel, venue operators, transportation companies, prize providers, or any other persons providing any prize-related services or accommodations. 5. **HOW TO CLAIM YOUR PRIZE:** Digital prizes will be fulfilled within 30 days by deposit into confirmed winners Dell Rewards Account and are not redeemable for cash and will not be replaced if lost, deleted, or not used. Digital prizes are subject to the Dell Rewards Program terms. No substitution or transfer of any prize to a third party is permitted and prizes cannot be redeemed for cash value, except by the Sponsor, who reserves the right in its sole discretion to substitute any prize, at its sole discretion. The Grand Prize winner must execute and return an Affidavit of Eligibility, a Liability Release, and (where imposing such condition is legal) a Publicity Release (collectively, **"Prize Claim Documents"**). If such winner fails or refuses to sign and return all Prize Claim Documents within five (5) days of prize notification (or a shorter time if required by exigencies), such

winner may be disqualified and an alternate winner may be selected. The ARV of any prize is based on available information provided to Sponsor and the actual retail value of any prizes awarded to a winner collectively valued at \$600 or more will be reported for tax purposes as required by law. Winner(s) of prizes collectively valued at \$600 or more will be issued a 1099 tax form following the receipt of the prize. 8. **RELEASE, HOLD HARMLESS AND INDEMNIFICATION:** As a condition of entering, entrants agree (and agree to confirm in writing): TO INDEMNIFY AND HOLD HARMLESS PROMOTION ENTITIES FROM ANY CLAIMS, ACTIONS, LOSSES, LIABILITIES, COSTS AND EXPENSES (INCLUDING BUT NOT LIMITED TO ATTORNEYS' FEES), INJURY, LOSS OR DAMAGES OF ANY KIND (COLLECTIVELY, "CLAIMS"), RESULTING FROM PARTICIPATING IN THE PROMOTION OR ANY CLAIMS ARISING FROM THE ACCEPTANCE, POSSESSION, OR USE OR MISUSE OF THE PRIZE AWARDED OR PARTICIPATION IN ANY PRIZE-RELATED ACTIVITY. ENTRANTS AGREE THAT PROMOTION ENTITIES HAVE NOT MADE NOR ARE IN ANY MANNER RESPONSIBLE OR LIABLE FOR ANY WARRANTY, REPRESENTATION, OR GUARANTEE, STATUTORY, EXPRESS OR IMPLIED (INCLUDING BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF MERCHANTABILITY, TITLE, AND FITNESS FOR A PARTICULAR PURPOSE), IN FACT OR IN LAW, RELATIVE TO THE PROMOTION OR THE PRIZE AWARDED. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of such term or any other provision. Sponsor reserves the right to disqualify any entrant who violates these Official Rules, any other rules, guidance or instructions set out by the Sponsor in promotional material relating to the Promotion or interferes with the Promotion in any manner. If an entrant is disqualified, Sponsor reserves the right to terminate such entrant's eligibility to participate in the Promotion. Any attempt by an individual to access any website associated with the Promotion via a bot script or other brute force attack or any other unauthorized means will result in that individual's IP address and all entries from that IP address becoming ineligible. Use of automated entry devices or programs is prohibited. Without limiting the generality of the foregoing, each entrant agrees to release and hold harmless the Promotion Entities from and against any and all claims based on publicity rights, defamation, invasion of privacy, copyright infringement, trademark infringement or any other intellectual property related cause of action that relate in any way to the Entry.
9. **Disputes:** Except where prohibited, Entrant agrees that any and all disputes, claims and causes of action arising out of, or connected with, the Promotion or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by United States District Court for the Western District of Texas and the Texas State District Court in Williamson County, Texas. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, Entrant's rights and obligations, or the rights and obligations of the Sponsor in connection with the Promotion, shall be governed by, and construed in accordance with, the laws of the State of Texas, without giving effect to any choice of law or conflict of law rules (whether of the State of Texas or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Texas.
10. **ADDITIONAL TERMS:**
- a. Sponsor reserves the right in its sole discretion to cancel, modify and/or suspend this Promotion at any time if fraud, technical failures, including any network server or

hardware failure, viruses, bugs, errors in programming, or any other errors or other causes (such as force majeure events) impairs the administration, security, integrity or proper play of the Promotion. In the event of cancellation, Sponsor reserves the right in its sole discretion, to randomly select any remaining winners from among all eligible, non-suspect entries received up to time of such cancellation. In no event will the Sponsor be liable for more than the stated number of prizes in these Official Rules.

- b. The Promotion Entities do not warrant that access to the Promotion will be uninterrupted. The Promotion Entities are not responsible for any problems that may arise, including but not limited to: (a) lost, interrupted, inaccessible or unavailable networks, servers, satellites, Internet Service Providers, websites, or other connection, availability or accessibility problems arising in connection with or over the course of the Promotion; or (b) communications failed, jumbled, scrambled, delayed, or misdirected computer, telephone or cable transmissions or hardware or software malfunctions, failures or difficulties; or (c) failure of personal computers and/or software and hardware configurations, any technical malfunctions, failures, or difficulties, printing errors, clerical, typographical or other error in connection with the administration of the Promotion, the processing of points or entries, or the offering or announcement of any prize or in any winner notification documents; or (d) for any other errors of any kind relating to or in connection with the Promotion, whether human, mechanical, clerical, electronic, or technical in nature; or (e) the incorrect or inaccurate capture of information, or the failure to capture any information in connection with the Promotion; or (f) damage to a user's system occasioned by participation in this Promotion or downloading any information necessary to participate in this Promotion. 11. DISCLOSURES:

- a. Any attempt by an entrant or other individual, to deliberately damage any website or undermine the legitimate operation of this Promotion, including but not limited to any fraudulent claims, may be a violation of criminal and civil laws. Should such an attempt be made, Sponsor reserves the right to seek remedies and damages (including attorneys' fees) from any such individual, to the fullest extent permitted by law, including criminal prosecution. Entrants engaging in any of the foregoing activities may be disqualified (and all associated entries will be void) and will forfeit any prize won. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
- b. Notwithstanding anything elsewhere in these Official Rules, no person's or entity's liability for death or personal injury caused by its negligence shall be limited in any way, and nor shall their ability for fraud or for any other matter where liability may not as a matter of law be limited or excluded. Where these Official Rules provide for discretion exercisable by a Promotion Entity that could otherwise be capable of causing a significant imbalance in the parties' rights and obligation hereunder, to the detriment of a consumer and contrary to the requirement of good faith, shall be exercised reasonably and in good faith.
