

**Soleil® Escape™ Razor Promotion**  
**OFFICIAL RULES**

**NO PURCHASE NECESSARY**

**PROMOTION DESCRIPTION:** Soleil® Escape™ Razor Promotion (the “**Promotion**”) takes place from April 15, 2024 at 12:00:01 a.m. Eastern Time (“**ET**”) to July 31, 2024 at 11:59:59 p.m. ET (the “**Promotion Period**”). The Promotion consists of a random draw sweepstakes (the “**Sweepstakes**”) wherein ten (10) Grand Prizes will be awarded in a random drawing at the end of the Promotion Period from among all eligible entries received during the Promotion Period and an online instant win game (“**Instant Win**”) wherein Instant Win prizes will be awarded, as described herein. Participation in the Promotion does not constitute participation in any other promotion, contest or sweepstakes. By participating in the Promotion, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of BIC USA Inc. 1 BIC Way STE 1, Shelton, CT 06484 (“**Sponsor**”), which shall be final and binding in all respects.

**ELIGIBILITY:** Only legal United States residents residing in the fifty (50) United States and Washington D.C., who are eighteen (18) years of age and older are eligible to participate. Once you have completed a Game, you will be informed immediately if you have won an Instant Win prize for that Game, subject to verification of eligibility. Once you have completed all five (5) Games, you will receive one (1) entry into the Sweepstakes.

**TEXT AND DATA CHARGES MAY APPLY.** By registering for the Promotion, you are consenting to receive up to two (2) reply text messages per entry regarding the Promotion. Consent is not a condition of entry. Your text is your electronic signature agreeing to these Official Rules and to giving electronic written consent. Participants must have a mobile phone with text messaging capabilities to participate. Participants may incur a standard text message charge from their wireless service provider for each message sent and received.
