PROMOTION DESCRIPTION: Soleil ${ }^{\circledR}$ Escape ${ }^{\mathrm{TM}}$ Razor Promotion (the "Promotion") takes place from April 15, 2024 at 12:00:01 a.m. Eastern Time ("ET") to July 31, 2024 at 11:59:59 p.m. ET (the "Promotion Period").
