

## **Clorox PURE Allergen Attacker Promotion OFFICIAL RULES**

### **NO PURCHASE NECESSARY**

**PROMOTION DESCRIPTION:** The Clorox PURE Allergen Attacker Promotion (the “**Promotion**”) begins on April 29, 2026 at 12:00:01 p.m. Pacific Time (“**PT**”) and ends on June 24, 2026 at 11:59:59 a.m. PT (the “**Promotion Period**”). The Promotion consists of a random draw sweepstakes (the “**Sweepstakes**”) wherein one (1) “**Sweepstakes Prize**” (as defined below) will be awarded in a random drawing at the end of the Promotion Period from among all eligible entries received during the Promotion Period and an online instant win game (“**Instant Win**”) wherein Instant Win prizes will be awarded, as described herein. Participation in the Promotion does not constitute participation in any other promotion, contest or sweepstakes. By participating in the Promotion, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of The Clorox Company, 1221 Broadway, Oakland, CA 94612 (“**Sponsor**”), which shall be final and binding in all respects.

**ELIGIBILITY:** Only legal United States residents residing in the fifty (50) United States and Washington D.C. who are eighteen (18) years of age or older are eligible to participate. **Instant Win Prize Winner Determination:** One (1) computer generated winning time will be randomly generated for each Instant Win prize available in this Promotion.
