OFFICIAL RULES

PROMOTION DESCRIPTION: The Clorox Catch the Freshness Promotion (the “**Promotion**”) begins on February 9, 2026 at 12:00:01 p.m. Pacific Time (“**PT**”) and ends on April 8, 2026 at 11:59:59 a.m. PT (the “**Promotion Period**”). The Promotion consists of a random draw sweepstakes (the “**Sweepstakes**”) wherein one (1) “Sweepstakes Prize” (as defined below) will be awarded in a random drawing at the end of the Promotion Period from among all eligible entries received during the Promotion Period and an online instant win game (“**Instant Win**”) wherein Instant Win prizes will be awarded, as described herein. Participation in the Promotion does not constitute participation in any other promotion, contest or sweepstakes. By participating in the Promotion, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of The Clorox Company, 1221 Broadway, Oakland, CA 94612 (“**Sponsor**”), which shall be final and binding in all respects.

ELIGIBILITY: Only legal United States residents residing in the fifty (50) United States and Washington D.C. who are eighteen (18) years of age or older are eligible to participate. Employees, officers and directors of Sponsor, CataBoom Technologies LLC (“**Administrator**”), their respective parents, subsidiaries, affiliates, distributors, retailers, sales representatives, advertising and promotion agencies (collectively, the “**Promotion Entities**”) and the immediate family members, and/or those living in the same household of each are ineligible to participate in the Promotion or win a prize. Promotion is void where prohibited by law.

Then, complete the registration form in its entirety and submit your registration. Once you have completed the registration form, you will be informed immediately if you have won an Instant Win prize, subject to verification of eligibility and receive one (1) entry into the Sweepstakes.

Limit one (1) entry per person per day during the Promotion Period. For purposes of these Official Rules, a ‘day’ is defined as any twenty-four (24) hour period during the Sweepstakes Period beginning at 12:00 a.m. PT and ending twenty-four (24) hours later at 11:59 p.m. PT.

By participating in this Promotion, you consent for Sponsor to obtain, use, and transfer your name, address, email and other details for prize fulfillment purposes and marketing, advertising and other commercial purposes as set forth in Sponsor's Privacy Policy available at <https://www.thecloroxcompany.com/privacy/>.

Instant Win Prize Winner Determination: One (1) computer generated winning time will be randomly generated for each Instant Win prize available in this Promotion. If you are the first participant to play the game at or after one of the randomly generated times, you will be a potential winner of the Instant Win prize indicated, subject to verification of eligibility. If you are a potential Instant Win prize winner, you will be provided with instructions on how to claim your Instant Win prize during your online session. If you receive a message that contains any message other than a winning message, you are not an Instant Win prize winner.

The Promotion Entities shall not be responsible for incorrect or inaccurate entry information whether caused by internet users or by any of the equipment or programming associated with or utilized in the Promotion or by any technical or human error which may occur in the processing of the entries in the Promotion. The Promotion Entities assume no responsibility or liability for any error, omission, interruption, deletion, theft or destruction, or unauthorized access to, or

The use of any device to automate the entry process is prohibited and will lead to disqualification. All entries become the property of Sponsor.

In the event of a dispute over the identity of a potential winner, entry will be deemed completed by the authorized account holder of the email address associated with the winning registration as long as such person is otherwise eligible in accordance with these Official Rules. "Authorized account holder" is defined as the natural person who is assigned to an email address by an internet access provider, on-line service provider, wireless carrier or other organization (e.g., business, educational institution, etc.) that is responsible for assigning email addresses for the domain associated with the submitted email address.

The potential Sweepstakes Prize winner will be notified by e-mail, using contact information associated with the potential Sweepstakes Prize winner's Promotion registration. Sponsor/Administrator shall have no liability for any potential Sweepstakes Prize winner notification that is lost, intercepted or not received by a potential winner for any reason. If, despite reasonable efforts, a potential Sweepstakes Prize winner does not respond within seventy-two (72) hours of the first notification attempt, or if the Sweepstakes Prize or Sweepstakes Prize notification is returned as unclaimed or undeliverable to such potential winner, such potential winner will forfeit their Sweepstakes Prize and an alternate winner may be selected. Sponsor, in its sole discretion, will attempt to contact up to three (3) alternate potential winners of a Sweepstakes Prize in accordance with the above procedure, after which the Sweepstakes Prize in question may go unawarded if it remains unclaimed. Sponsor reserves the right to modify, extend, suspend or terminate the Promotion if it determines, in its sole discretion, that the Promotion is technically impaired or corrupted or that fraud or technical problems, failures or malfunctions or other causes beyond Sponsor’s control have destroyed or severely undermined or to any degree impaired the integrity, administration, security, proper play and/or feasibility of the Promotion as contemplated herein.
