# Kingsford "Sizzle or Fizzle" Game OFFICIAL RULES

## NO PURCHASE NECESSARY

**PROMOTION DESCRIPTION:** The Kingsford "Sizzle or Fizzle" Game (the "**Promotion**") begins on May 1, 2025 at 9:00:01 a.m. Pacific Time ("**PT**") and ends on July 31, 2025 at 9:00:00 a.m. PT (the "**Promotion Period**"). The Promotion Period will consists of three (3) separate entry periods (each, an "**Entry Period**" and collectively, the "**Entry Periods**") taking place as follows:

The Promotion consists of a random draw sweepstakes (the "Sweepstakes") wherein four (4) "Sweepstakes Prizes" (as defined below) will be awarded in a random drawing at the end of each Entry Period from among all eligible entries received during the corresponding Entry Period (for a total of twelve (12) total Sweepstakes Prizes throughout the Promotion Period) and an online instant win game ("Instant Win") wherein Instant Win prizes will be awarded, as described herein. Participation in the Promotion does not constitute participation in any other promotion, contest or sweepstakes. Once you have completed the game, you will be informed immediately if you have won an Instant Win prize, subject to verification of eligibility and receive one (1) entry into the Sweepstakes.

Instant Win Prize Winner Determination: One (1) computer generated winning time will be randomly generated for each Instant Win prize available in this Promotion.
