

**Kingsford "Sizzle or Fizzle" Game
OFFICIAL RULES**

NO PURCHASE NECESSARY

PROMOTION DESCRIPTION: The Kingsford “Sizzle or Fizzle” Game (the “**Promotion**”) begins on May 1, 2025 at 9:00:01 a.m. Pacific Time (“**PT**”) and ends on July 31, 2025 at 9:00:00 a.m. PT (the “**Promotion Period**”). The Promotion Period will consists of three (3) separate entry periods (each, an “**Entry Period**” and collectively, the “**Entry Periods**”) taking place as follows:

The Promotion consists of a random draw sweepstakes (the “**Sweepstakes**”) wherein four (4) “Sweepstakes Prizes” (as defined below) will be awarded in a random drawing at the end of each Entry Period from among all eligible entries received during the corresponding Entry Period (for a total of twelve (12) total Sweepstakes Prizes throughout the Promotion Period) and an online instant win game (“**Instant Win**”) wherein Instant Win prizes will be awarded, as described herein. Participation in the Promotion does not constitute participation in any other promotion, contest or sweepstakes. By participating in the Promotion, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of The Clorox Company, 1221 Broadway, Oakland, CA 94612 (“**Sponsor**”), which shall be final and binding in all respects.

ELIGIBILITY: Only legal United States residents residing in the fifty (50) United States and Washington D.C. who are eighteen (18) years of age or older and are and have a Kingsford account (an “**Account**”) are eligible to participate. Employees, officers and directors of Sponsor, CataBoom Technologies LLC (“**Administrator**”), their respective parents, subsidiaries, affiliates, distributors, retailers, sales representatives, contractors, advertising and promotion agencies (collectively, the “**Promotion Entities**”) and the immediate family members, and/or those living in the same household of each are ineligible to participate in the Promotion or win a prize. Promotion is void where prohibited by law.

HOW IT WORKS: During the Promotion Period, go to <https://www.kingsford.com> (the “**Website**”) and log-in to your Account. Then, locate the link to the Promotion and follow the on-screen instructions to play the game. Once you have completed the game, you will be informed immediately if you have won an Instant Win prize, subject to verification of eligibility and receive one (1) entry into the Sweepstakes.

Limit one (1) play and entry per person per day. For purposes of these Official Rules, a ‘day’ is defined as any twenty-four (24) hour period during the Sweepstakes Period beginning at 9:01 a.m. PT and ending twenty-four (24) hours later at 9:00 a.m. PT.

By participating in this Promotion, you consent for Sponsor to obtain, use, and transfer your name, address, email and other details for prize fulfillment purposes and marketing, advertising

and other commercial purposes as set forth in Sponsor's Privacy Policy available at <https://www.thecloroxcompany.com/privacy/>.

Instant Win Prize Winner Determination: One (1) computer generated winning time will be randomly generated for each Instant Win prize available in this Promotion. If you are the first participant to play the game at or after one of the randomly generated times, you will be a potential winner of the Instant Win prize indicated, subject to verification of eligibility. If you are a potential Instant Win prize winner, you will be provided with instructions on how to claim your Instant Win prize during your online session. If you receive a message that contains any message other than a winning message, you are not an Instant Win prize winner.

In the event of a dispute over the identity of a potential winner, entry will be deemed completed by the authorized account holder of the email address associated with the winning registration as long as such person is otherwise eligible in accordance with these Official Rules. "Authorized account holder" is defined as the natural person who is assigned to an email address by an internet access provider, on-line service provider, wireless carrier, or other organization (e.g., business, educational institution, etc.) that is responsible for assigning email addresses for the domain associated with the submitted email address.

If due to technical, production or other errors, more prizes are claimed than intended, the intended prize will be awarded in a random drawing from all those submitting purportedly valid claims. SWEEPSTAKES PRIZE WINNER SELECTION AND NOTIFICATION: At the conclusion of each Entry Period, four (4) potential Sweepstakes Prize ("Sweepstakes Prize") winners will be randomly selected from all eligible entries received during the Promotion Period. The potential Sweepstakes Prize winners will be notified by telephone and/or e-mail, using contact information associated with the potential Sweepstakes Prize winner's Account. Sponsor/Administrator shall have no liability for any potential Sweepstakes Prize winner notification that is lost, intercepted

or not received by a potential winner for any reason. If, despite reasonable efforts, a potential Sweepstakes Prize winner does not respond within seventy-two (72) hours of the first notification attempt, or if the Sweepstakes Prize or Sweepstakes Prize notification is returned as unclaimed or undeliverable to such potential winner, such potential winner will forfeit their Sweepstakes Prize and an alternate winner may be selected. PRIZES/ODDS:

SWEEPSTAKES PRIZE:

Twelve (12) Sweepstakes Prizes are available (four (4) per Entry Period). Each Sweepstakes Prize consists of a Kingsford Pitmaster Pack with an approximate retail value (“ARV”) of \$1,100 each. Each Kingsford Pitmaster Pack includes:

Sponsor reserves the right in its sole discretion to disqualify any individual who is found to be tampering with the entry process or the operation of the Promotion, to be acting in violation of these Official Rules, or to be acting in an unsportsmanlike or disruptive manner, or with the intent to disrupt or undermine the legitimate operation of the Promotion, or to annoy, abuse, threaten or harass any other person, and Sponsor reserves the right to seek damages and other remedies from any such person to the fullest extent permitted by law. No mechanically reproduced, illegible, incomplete, forged, software-generated or other automated multiple entries will be accepted. Inclusion in such drawing shall be each entrant's sole and exclusive remedy under such circumstances.
