The Promotion consists of a random draw sweepstakes (the "**Sweepstakes**") wherein one (1) "Sweepstakes Prize" (as defined below) will be awarded in a random drawing at the end of the Promotion Period from among all eligible entries received during the Promotion Period and an online instant win game ("**Instant Win**") wherein Instant Win prizes will be awarded, as described herein. Participation in the Promotion does not constitute participation in any other promotion, contest or sweepstakes.
