## FLX Rewards Sneaker Slots Instant Win Game - Aug. 2024 Official Rules

# NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

- **1. Eligibility:** FLX Rewards Sneaker Slots Instant Win Game Aug. 2024 (the "Promotion") is open only to legal residents of the fifty (50) United States (including the District of Columbia) who are at least thirteen (13) years old and in good standing at the time of entry. Membership is free but subject to the listed <u>Terms and Conditions</u>. Employees of Foot Locker Retail, Inc., Cataboom Technologies, LLC, and their parent and affiliate companies, suppliers as well as the immediate family (spouse, parents, siblings and children) and household members of each such employee are not eligible. The Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited. - **3. Timing:** The Promotion begins on August 14<sup>th</sup>, 2024 at 12:00 a.m. Eastern Time ("ET") and ends on August 27<sup>th</sup>, 2024 at 11:59 p.m. ET (the "Promotion Period"). Administrator's computer is the official time-keeping device for this Promotion.

#### 4. How to Enter:

#### a. Instant Win Game:

- Using points: Log into your FLX Rewards Program account to access this Instant Win Game. Follow the instructions to redeem 1,000 points for one (1) entry. Once your points are redeemed for an entry into this Instant Win Game, the points will automatically be removed from your account. You will receive one (1) Instant Win Game play. Click the link to navigate to the Instant Win Game page. You can play up to five times per day. Once on the Instant Win Game page, the Instant Win Game results will be instantly displayed. Potential winners of the Instant Win Game will be provided directions for validation. All potential winners are subject to verification before any prize will be awarded. Administrator is responsible for the functionality of the Instant Win Game. - ii. Alternate Method of Entry: To enter without redeeming FLX Rewards points, visit https://secure.cataboom.com/direct/flx-rewards-amoe to complete and submit a digital form with your email address associated with your FLX Rewards account during the Entry Period. Upon submitting the registration form, you will receive an email with a link to complete the entry. After clicking the link, complete and submit a digital form with your full name, phone number, street address, city, state and zip code during the Entry Period. Upon submitting this form, the system will determine if you are a potential instant winner and display key information required for your mail-in submission. A mail-in submission is required to find out the outcome of your play. Neatly print, or print out and tape the key information that was displayed upon submission of your form on a 3X5 postcard. All information displayed must be provided on the postcard to qualify. Entries must be postmarked within three (3) calendar days of the end of the Entry Period.
