

FLX x Champs Sports Month of Miles Sweepstakes Official Rules

No Purchase Necessary. A Purchase Will Not Increase Your Chances of Winning.

- 1. Eligibility:** The FLX x Champs Sports Month of Miles Sweepstakes (the “Sweepstakes”) is open only to legal residents of the United States who are at least 13+ years of age at the time of entry and are members of the Foot Locker FLX Program in good standing. Entrants under the age of eighteen (18) years (or the age of majority in their jurisdiction of legal residence) must have the permission of their parent or legal guardian to enter and/or win and will need to have a parent or legal guardian sign any required documents for winner validation. Employees of Foot Locker Retail, Inc. (“Sponsor”), as well as the immediate family (spouse, parents, siblings, and children) and household members of those employees, are not eligible to enter.
- 2. Entry Period: The Sweepstakes begins at 12:00 AM ET May 1st, 2026 and ends at 11:59 PM ET on May 31st, 2026. (“Entry Period”). The Entry Period consists of four weekly entry periods (each, a “Weekly Entry Period”): (a) Week 1 entry period begins at 12:00 AM ET on May 1, 2026 and ends at 11:59 PM ET on May 7, 2026 (“Week 1”); (b) Week 2 entry begins at 12:00 AM ET on May 8, 2026 and ends at 11:59 PM ET on May 14, 2026 (“Week 2”); (c) Week 3 entry period begins at 12:00 AM ET on May 15, 2026 and ends at 11:59 PM ET on May 21, 2026 (“Week 3”); (d) Week 4 entry period begins at 12:00 AM ET on May 22, 2026 and ends at 11:59 PM ET on May 31, 2026 (“Week 4”).**

Entries submitted before or after the Entry Period will not be eligible. Sponsor’s computer is the official time-keeping device for the Sweepstakes.

- 3. How to Enter:**
 - a)** To enter the Promotion during the Entry Period, an eligible entrant (“Entrant”) must complete and submit the official entry form with the following required information: Entrant’s name, FLX Rewards-associated email address, and the number of miles the Entrant ran and/or walked during the applicable calendar week. Entrants may also optionally indicate the fitness tracking service they use (not required for a completed entry). FLX Rewards members may access the entry form by (i) navigating to the “Earn” tab within the [FLX Dashboard](#) and clicking the applicable link, or (ii) visiting the Promotion directly via the designated [link](#). All entries must be submitted in accordance with the on-screen instructions. The number of miles reported has no impact on an Entrant’s chances of winning. All eligible entries will receive one (1) entry, and the winner(s) will be selected at random from among all eligible entries received during the Entry Period.
 - b) For all Entries:** An eligible member may enter up to four (4) times total during the Promotion by submitting one (1) entry in each Weekly Entry Period. Entries will be included only in the drawing associated with the Weekly Entry Period during which the entry is submitted. Members who enter during multiple Weekly Entry Periods will be eligible for the drawing(s) corresponding solely to the period(s) in which they entered. Each Weekly Entry Period has a separate drawing for a distinct prize. For clarity, entries from one Weekly Entry Period do not carry over to subsequent drawings. Any entries

attempted through the use of agencies, robotic, repetitive, automatic, programmed, or similar methods will be void. Participation in the Promotion constitutes Entrant's full and unconditional agreement to these Official Rules and to the decisions of the Sponsor, which are final and binding in all matters relating to the Promotion. Winning a prize is contingent upon fulfilling all requirements set forth herein.

4. **Drawing:** Sponsor will conduct four (4) separate random drawings, with one (1) potential winner selected per drawing, from among all eligible entries received during the applicable Weekly Entry Period, as outlined below. Each drawing will be conducted by Sponsor or a third party designated by Sponsor. The odds of winning depend on the total number of eligible entries received for each applicable drawing period.
 - a) Drawing schedule:
 - i. Week 1 Drawing - May 8, 2026: From all eligible entries received between May 1, 2026 and May 7, 2026 ("Week 1")
 - ii. Week 2 Drawing May 15, 2026: From all eligible entries received between May 8, 2026 and May 14, 2026 ("Week 2")
 - iii. Week 3 Drawing May 22, 2026: From all eligible entries received between May 15, 2026 and May 21, 2026 ("Week 3")
 - iv. Week 4 Drawing June 1, 2026: From all eligible entries received between May 22, 2026 and May 31, 2026 ("Week 4")

Each eligible entry will be included only in the drawing associated with the Weekly Entry Period during which it was submitted. Sponsor will attempt to notify each potential winner ("Winner") via email and/or text message within five (5) days following the applicable drawing date. Sponsor will make up to two (2) notification attempts. If a potential Winner does not respond within three (3) days of Sponsor's notification attempt(s), the potential Winner may be disqualified and an alternate potential winner may be selected at random from among the remaining eligible entries received for the applicable drawing period.

5. **Potential Winner Requirements:** Except where prohibited, a potential winner may be required to complete and return a declaration of eligibility and liability/publicity release. If the potential winner is a minor in his/her jurisdiction of residence, Sponsor reserves the right to award the prize to the potential winner's parent or legal guardian, who must also execute all documents on behalf of the minor. If a potential winner (or his parent/legal guardian, where applicable) fails to sign and return these documents within the required time period, and time permits, an alternate potential winner may be selected in his/her place in a random drawing of all remaining entries received. Sponsor will attempt to contact a maximum of three (3) alternate potential winners.
6. **Prize:** Four (4) prizes total will be awarded, one (1) prize per drawing, as outlined below. Each potential winner will receive only the prize associated with the applicable weekly drawing.
 1. Week 1 Prize: One (1) pair of Apple AirPods Pro 3 Wireless Earbuds (ARV is \$224) and one (1) \$150 Champs Sports gift card (ARV is \$150). Week 1 total ARV is \$374.
 2. Week 2 Prize: One (1) pair of SHOKZ OpenRun Pro 2 Bone Conduction Headphones (ARV is \$179) and one (1) \$150 Champs Sports gift card (ARV is \$150). Week 2 total ARV is \$329.
 3. Week 3 Prize: One (1) TheraGun Therabody Relief Handheld Percussion Massage Gun (ARV is \$159) and one (1) \$150 gift card (ARV is \$150). Week 3 total ARV is \$309.

4. Week 4 Prize: One (1) Garmin Forerunner 165 (ARV is \$199) and one (1) \$150 Champs Sports gift card (ARV is \$150). Week 4 total ARV is \$349

The total ARV of all prizes is \$1,361. Winner is responsible for paying any applicable income taxes and all other costs and expenses not listed above, including without limitation income taxes and any other taxes, all transportation (including without limitation flights, ground transportation, taxi and/or ride share fares), meals, snacks, beverages, and food, parking, incidentals, tips, telephone calls, hotel, room service, souvenirs, gratuities, items of a personal nature and other costs, fees or surcharges, including those incurred by the Winner and Guest.

All prize details, including those not specified above, will be determined by Sponsor, in its sole discretion. A prize may not be transferred prior to award and must be accepted as awarded. A Winner may not request cash or a substitute prize; however, Sponsor reserves the right to substitute a prize with another prize of equal or greater value if the advertised prize is not available for any reason, as determined by Sponsor, in its sole discretion.

7. **General Conditions:** In the event that the operation, security, or administration of the Sweepstakes is impaired in any way, Sponsor may, in its sole discretion, either: (a) suspend the Sweepstakes to address the impairment and then resume the Sweepstakes; or (b) award the prize at random from among the eligible entries received up to the time of the impairment. Sponsor reserves the right, in its sole discretion, to disqualify and seek damages from any individual who tampers with the operation of the Sweepstakes, violates these Official Rules, or acts in a disruptive or unsportsmanlike manner. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision. Proof of sending any communication to Sponsor by mail shall not be deemed proof of receipt of that communication. The Sweepstakes is subject to federal, state, provincial, and local laws and regulations, and is void where prohibited.
8. **Privacy and Publicity:** Any information you submit as part of the Sweepstakes will be used in accordance with Sponsor's [Privacy Statement](#). Except where prohibited, participation in the Sweepstakes constitutes your consent to Sponsor's use of your name, likeness, voice, opinions, biographical information, state of residence, and any posts you make with the #BornToFLX hashtag for promotional purposes in any media without further payment or consideration.
9. **Release and Limitations of Liability:** By entering, you agree to release and hold harmless Sponsor and their respective parents, subsidiaries, affiliates, and advertising and Sweepstakes agencies, and each of their respective officers, directors, employees, and agents (collectively, the "Released Parties") from and against any claim or cause of action arising out of participation in the Sweepstakes or receipt or use of any prize, including, but not limited to (a) unauthorized human intervention in the Sweepstakes; (b) technical errors related to computers, servers, providers, or telephone or network lines; (c) any errors on the social media platforms that may prevent an individual from participating or receiving direct messages; (d) printing errors; (e) lost, late, postage-due, misdirected, or undeliverable mail; (f) errors in the administration of the Sweepstakes or the processing of posts; or (g) injury or damage to persons or property. You further agree that for any cause of action, in no event shall the Released Parties be liable for

attorneys' fees or other legal costs. You waive the right to claim any damage whatsoever, including, but not limited to, punitive, consequential, direct, or indirect damages.

10. **Disputes:** You agree that any and all disputes, claims and causes of action arising out of, or connected with, the Sweepstakes or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate court located in New York. All issues and questions concerning the construction, validity, interpretation, and enforceability of these Official Rules, your rights and obligations, or the rights and obligations of the Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of New York, without giving effect to any choice of law or conflict of law rules (whether of New York or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than New York.
