OFFICIAL RULES

NO PURCHASE NECESSARY

PROMOTION DESCRIPTION: Hilton South Farm Strong Challenge Sweepstakes (the “**Promotion**”) begins on or about January 6, 2022 at 12:00:00am Central Time (“CT”) and ends on February 20, 2022 at 11:59:59pm CT (the “**Promotion Period**”). Participation in the Promotion does not constitute participation in any other promotion, contest or sweepstakes. By participating in the Promotion, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Iowa Farm Bureau Federation, 5400 University Avenue, West Des Moines, IA 50266 and Cyclone Sports Properties, LLC, 10609 Justin Drive, Urbandale, IA 50322. (“**Sponsor**”), which shall be final and binding in all respects.

ELIGIBILITY: Only legal United States residents residing the fifty (50) United States and District of Columbia (U.S.) who are eighteen (18) years of age or older are eligible to participate. Employees, officers and directors of **Sponsor**, and each of their respective parents, subsidiaries, affiliates, distributors, retailers, sales representatives, advertising and promotion agencies (collectively, the “**Promotion Entities**”) and the immediate family members, and/or those living in the same household of each are ineligible to participate in the Promotion or win a prize are not eligible to participate. In the event of a dispute over the identity of an entrant, entry will be deemed completed by the authorized account holder of the email address provided at time of registration.
