

**Pine-Sol Clean Sweep Promotion
OFFICIAL RULES**

NO PURCHASE NECESSARY

PROMOTION DESCRIPTION: The Pine-Sol Clean Sweep Promotion (the “**Promotion**”) begins on September 3, 2026 at 12:00:01 p.m. Pacific Time (“**PT**”) and ends on September 2, 2027 at 11:59:59 a.m. PT (the “**Promotion Period**”). The Promotion Period will consist of four (4) separate participation periods (each, a “**Participation Period**” and collectively, the “**Participation Periods**”) taking place as follows:

The Promotion consists of an online instant win game (“**Instant Win**”) wherein four (4) Instant Win prizes will be available each week of each Participation Period, as described herein. For purposes of these Official Rules, each week begins each Thursday of the Promotion Period at 12:00:01 p.m. PT and ends seven days later, each Thursday of the Promotion Period, at 11:59:59 a.m. PT. Participation in the Promotion does not constitute participation in any other promotion, contest or sweepstakes. By participating in the Promotion, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of The Clorox Company, 1221 Broadway, Oakland, CA 94612 (“**Sponsor**”), which shall be final and binding in all respects.

ELIGIBILITY: Only legal United States residents residing in the fifty (50) United States and Washington D.C. who are eighteen (18) years of age or older are eligible to participate. Employees, officers and directors of Sponsor, CataBoom Technologies LLC (“**Administrator**”), their respective parents, subsidiaries, affiliates, distributors, retailers, sales representatives, contractors, advertising and promotion agencies (collectively, the “**Promotion Entities**”) and the immediate family members, and/or those living in the same household of each are ineligible to participate in the Promotion or win a prize. Once you have completed the game, you will be informed immediately if you have won an Instant Win prize, subject to verification of eligibility and compliance with these Official Rules.

Limit one (1) play per person per day. For purposes of these Official Rules, a ‘day’ is defined as any twenty-four (24) hour period during the Promotion Period beginning at 12:00:01 p.m. PT and ending twenty-four (24) hours later at 11:59:59 a.m. PT.

By participating in this Promotion, you consent for Sponsor to obtain, use, and transfer your name, address, email and other details for prize fulfillment purposes and marketing, advertising and other commercial purposes as set forth in Sponsor's Privacy Policy available at <https://www.thecloroxcompany.com/privacy/>.

Instant Win Prize Winner Determination: Four (4) computer-generated winning times will be randomly generated each week of each Participation Period throughout the Promotion Period. If you are the first participant to play the game at or after one of the randomly generated times, you will be a potential winner of the Instant Win prize indicated, subject to verification of eligibility. If you are a potential Instant Win prize winner, you will be provided with instructions on how to claim your Instant Win prize during your online session. If you receive a message that contains any message other than a winning message, you are not an Instant Win prize winner.

The Promotion Entities shall not be responsible for incorrect or inaccurate entry information, whether caused by internet users or by any of the equipment or programming associated with or utilized in the Promotion or by any technical or human error which may occur in the processing of the entries in the Promotion. In the event of a dispute over the identity of a potential winner, entry will be deemed completed by the authorized account holder of the email address associated with the winning registration as long as such person is otherwise eligible in accordance with these Official Rules. "Authorized account holder" is defined as the natural person who is assigned to an email address by an internet access provider, on-line service provider, wireless carrier or other organization (e.g., business, educational institution, etc.) that is responsible for assigning email addresses for the domain associated with the submitted email address.

Two Hundred Eight (208) Instant Win Prizes are available [four (4) per week] with an approximate retail value ("ARV") of \$80.98 each. Each Instant Win Prize consists of: one (1) pair of Mop and Move slippers with an ARV of \$25; one (1) Pine-Sol blanket with an ARV of \$45; one (1) Pine-Sol sponge with an ARV of \$6.70; and one (1) Pine-Sol 20 oz. scent with an ARV of \$4.28.
