

**Dallas Truck World Hit It Here Sweepstakes  
OFFICIAL RULES**

**NO PURCHASE NECESSARY**

**SWEEPSTAKES DESCRIPTION:** The Dallas Truck World Hit It Here Sweepstakes (the “**Sweepstakes**”) begins at 5:00:01 p.m. Central Time (“**CT**”) on April 5, 2021 and ends at 1:59:59 p.m. CT on October 3, 2021 (the “**Sweepstakes Period**”).

The Sweepstakes consists of the “Grand Prize Drawing” wherein should a member of the Texas Rangers Major League Baseball team hit a home run by completely hitting the target on the Dallas Truck World billboard at Global Life Stadium without the aid of any individual, surface or object during a regular season home game during the Sweepstakes Period (the “**Qualifying Event**”) as determined at the sole discretion of Sponsor, a representative of Sponsor will randomly selected one (1) potential Grand Prize winner to receive the “Grand Prize” (as defined below and subject to verification of eligibility and in compliance with these Official Rules) from among all eligible entries received as of the time the Qualifying Event occurs. There will only be one (1) Grand Prize available, regardless of the number of Qualifying Events that may occur during the Sweepstakes Period and entries into the Grand Prize Drawing will be accepted until the first time a Qualifying Event occurs. Additionally, there will be a “First Prize Drawing” to randomly select one (1) potential “First Prize” (as defined below) winner from among all eligible entries received, as described herein.

Entry in the Sweepstakes does not constitute entry in any other promotion, contest or sweepstakes. By participating in the Sweepstakes, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Southwest KIA d/b/a Dallas Truck World, 39650 Lyndon B. Johnson Freeway, Dallas, TX 75234 (“**Sponsor**”), which shall be final and binding in all respects.

**ELIGIBILITY:** Only legal United States residents who reside in Texas and are eighteen (18) years of age or older are eligible to participate. Employees, officers and directors of Sponsor, its parent, subsidiaries, affiliates, distributors, retailers, sales representatives, advertising and promotion agencies (collectively, the “**Sweepstakes Entities**”) and the immediate family members, and/or those living in the same household of each and employees, officers and directors of the “**MLB Entities**” (as defined below) and each of their respective parent companies, affiliates, and subsidiaries are not eligible to participate in the Sweepstakes are ineligible to participate in the Sweepstakes or receive a prize. For purposes of these Official Rules, the “**MLB Entities**” shall mean the Office of the Commissioner of Baseball (“**BOC**”), its Bureaus, Committees, Subcommittees and Councils, MLB Advanced Media, L.P. (“**MLBAM**”), Major League Baseball Properties, Inc., The MLB Network, LLC, the Major League Baseball Clubs (“**Clubs**”), which for clarity includes the Rangers Baseball LLC (“**Texas Rangers**”), each of their parent, subsidiary, affiliated and related entities, any entity which, now or in the future, controls, is controlled by, or is under common control with the Clubs or the BOC, and the owners, general and limited partners, shareholders, directors, officers, employees and agents of the foregoing entities. The MLB Entities are not responsible for the collection, submission or processing of entries or the administration of the Sweepstakes. Sweepstakes is void where prohibited by law.

**HOW TO ENTER:** During the Sweepstakes Period, go to [www.dallastruckworld.com](http://www.dallastruckworld.com) (the “**Website**”), complete the entry form with the information requested, and follow the on-screen instructions to submit your entry and receive one (1) entry into the Grand Prize Drawing and First Prize Drawing. All requested information on the entry form at the Website must be completed to

enter and to be eligible to win. Incomplete entries will be disqualified. Proof of entering information at the Website is not considered proof of delivery to or receipt by Sponsor of such entry. Except as contemplated in these Official Rules, personal information collected in connection with this Sweepstakes will be used in accordance with the privacy policy found on the Website.

NOTE: Internet entry must be made by the entrant, only at the Website. Entries made by any other individual or any entity, and/or originating at any other web site or e-mail address, including but not limited to commercial sweepstakes subscription notification and/or entering service sites, will be declared invalid and disqualified for this Sweepstakes. The use of any device to automate the entry process is prohibited.

Except as contemplated in these Official Rules, personal information collected in connection with this Sweepstakes will be used in accordance with Sponsor's Privacy Policy available at <https://www.southwestkia.com/privacy.htm>. **Limit one (1) entry per person and per email address during the Sweepstakes Period.**

All entries must be received by the end of the Sweepstakes Period in order to participate. The Website's database clock will be the official timekeeper for online entries in this Sweepstakes. The Sweepstakes Entities and MLB Entities shall not be responsible for incorrect or inaccurate entry information whether caused by Internet users or by any of the equipment or programming associated with or utilized in the Sweepstakes or by any technical or human error that may occur in the processing of the entries in the Sweepstakes. The Sweepstakes Entities and MLB Entities assume no responsibility or liability for any error, omission, interruption, deletion, theft or destruction, or unauthorized access to, or alteration of entries. NOTE: Entry must be by the entrant and only as directed in these Official Rules. Entry by any other individual or any entity, and/or originating at any website or other platform, including but not limited to commercial promotion subscription notification and/or entering service sites, will be declared invalid and disqualified for this Sweepstakes. The use of any device to automate the entry process is prohibited and will lead to disqualification.

In the event of a dispute over the identity of a potential winner, entry will be deemed completed by the authorized account holder of the email address associated with the member account used for entry. "Authorized account holder" is defined as the natural person who is assigned to an email address by an Internet access provider, on-line service provider, wireless carrier, or other organization (e.g., business, educational institution, etc.) that is responsible for assigning email addresses for the domain associated with the submitted email address.

**WINNER SELECTION AND NOTIFICATION:** If the Qualifying Event occurs, one (1) potential Grand Prize winner will be selected in a random drawing from among all eligible entries received as of the time the Qualifying Event occurs. At the end of the Sweepstakes Period, one (1) potential First Prize winner will be selected in a random drawing from among all eligible entries received during the Sweepstakes Period. The potential prize winner(s) will be notified by telephone and/or mail and/or e-mail, using contact information provided or collected at the time of entry. Sponsor shall have no liability for any winner notification that is lost, intercepted or not received by a potential winner for any reason. If, despite reasonable efforts, a potential winner does not respond within seventy-two (72) hours of the first notification attempt, or if the prize or prize notification is returned as unclaimed or undeliverable to such potential winner, such potential winner will forfeit his or her prize and an alternate winner may be selected. Sponsor, in its sole discretion, will attempt to contact up to three (3) potential winners of a prize in accordance with the above procedure, after which the prize in question may go unawarded if it

remains unclaimed. If any potential prize winner is found to be ineligible, or if he or she has not complied with these Official Rules or declines the prize for any reason prior to award, such potential prize winner will be disqualified and an alternate prize winner may be selected. **The odds of winning a Grand Prize depend on whether the Qualifying Event occurs and the number of eligible entries received as of the time the Qualifying Event occurs. The odds of winning a First Prize depend on the number of eligible entries received throughout the Sweepstakes Period.**

## **PRIZES:**

### Grand Prize:

One (1) Grand Prize is available solely if the Qualifying Event occurs. The Grand Prize consists of \$30,000 to be applied to the purchase of a vehicle at Dallas Truck World. The confirmed Grand Prize winner may select any used vehicle currently available in Dallas Truck World's inventory. Purchase must be completed by December 31, 2021. In the event the vehicle selected is less than \$30,000, the winner will NOT be entitled to a check, cash or other form of payment for the price difference. Grand Prize winner shall be solely responsible for all costs of the vehicle exceeding \$30,000. The Grand Prize winner may opt to receive \$30,000 cash (awarded in the form of a check payable to the Grand Prize winner) in lieu of the Grand Prize vehicle. **ALL FEDERAL, STATE AND LOCAL INCOME TAXES, AND ANY OTHER COSTS AND EXPENSES ASSOCIATED WITH THE RECEIPT OR USE OF THE VEHICLE ARE THE SOLE RESPONSIBILITY OF THE GRAND PRIZE WINNER.** No prize substitution or cash redemption of Grand Prize is allowed, except at Sponsor's sole discretion. Grand Prize winner is required to comply with all applicable federal, state and local laws, rules and regulations, including but not limited to licensing and insurance requirements. Title, taxes, registration, license, and similar fees, and insurance costs are the sole responsibility of the Grand Prize winner. Grand Prize winner must possess a valid U.S. driver's license. Grand Prize winner will be required to show proof of currently valid driver's license and state mandated insurance prior to taking delivery of the vehicle. The Grand Prize winner shall be responsible for personally taking delivery of the vehicle at a dealership in reasonably close proximity to the Grand Prize winner's permanent legal residence, as determined by the Sponsor. Grand Prize winner shall be solely responsible for all travel or transportation costs to and from the dealership. The vehicle will be delivered solely with the express written limited warranties set forth in the vehicle's applicable Owner's Guide, which warranties shall run for the term set forth in said guide. **THERE IS NO GUARANTEE THAT THE GRAND PRIZE WILL BE AWARDED.**

### First Prize:

One (1) First Prize is available. The First Prize (1) consists of two (2) Texas Rangers upper level 2022 half season tickets for Texas Rangers regular season home games consisting of 41 home games. Exact games are at the sole discretion of Sponsor. The approximate retail value ("ARV") of the First Prize is \$1,500.

All prize details are the sole discretion of Sponsor. No prize substitution or redemption for cash except by Sponsor due to unavailability of prize for any reason and then for prize of equal value, except as may be required by applicable law. No prize transfer except with Sponsor's permission which may be granted or withheld in its sole discretion without liability of any kind. All applicable taxes and unspecified expenses in conjunction with prize acceptance/use are prize winner's sole responsibility. Sponsor will report all prize winnings and their composite value to the Internal Revenue Service via IRS 1099 Tax Form; and, winner agrees to fully cooperate with

Sponsor as to their compliance with such tax reporting obligation by providing his/her Social Security Number via IRS W9 Tax Form.

**GENERAL PRIZE CONDITIONS:** Any potential winner must sign, have notarized, and return an Affidavit of Eligibility, a Liability Release, and (where imposing such condition is legal) a Publicity Release (collectively, “**Prize Claim Documents**”). If winner fails or refuses to sign and return all Prize Claim Documents within seventy-two (72) hours of prize notification (or a shorter time if required by exigencies), winner may be disqualified and an alternate winner may be selected.

Entrants agree that the Sweepstakes Entities and the MLB Entities (A) shall not be responsible or liable for, and are hereby released from, any and all costs, injuries, losses or damages of any kind, including, without limitation, death and bodily injury, due in whole or in part, directly or indirectly, to entry in the Sweepstakes or any Sweepstakes-related activity, or from entrants’ acceptance, receipt, possession and/or use or misuse of any prize, and (B) have not made any warranty, representation or guarantee express or implied, in fact or in law, with respect to any prize, including, without limitation, to such prize’s quality or fitness for a particular purpose. Sponsor assumes no responsibility for any damage to an entrant’s or any other person’s computer system or wireless phone which is occasioned by participating in the Sweepstakes, or for any computer system, phone line, hardware, software or program malfunctions, or other errors, failures, delayed computer transmissions or network connections that are human or technical in nature. Without limiting the generality of the foregoing, Sponsor is not responsible for incomplete, illegible, misdirected, misprinted, late, lost, damaged, stolen, or postage-due submissions or prize notifications; or for lost, interrupted, inaccessible or unavailable networks, servers, satellites, Internet service providers, websites, or other connections; or for miscommunications, failed, jumbled, scrambled, delayed, or misdirected computer, telephone or cable transmissions; or for any technical malfunctions, failures, difficulties or other errors of any kind or nature; or for the incorrect or inaccurate capture of information, or the failure to capture any information. Sponsor reserves the right in its sole discretion to disqualify any individual who is found to be tampering with the entry process or the operation of the Sweepstakes, to be acting in violation of these Official Rules, or to be acting in an unsportsmanlike or disruptive manner, or with the intent to disrupt or undermine the legitimate operation of the Sweepstakes, or to annoy, abuse, threaten or harass any other person, and Sponsor reserves the right to seek damages and other remedies from any such person to the fullest extent permitted by law. No mechanically reproduced, illegible, incomplete, forged, software-generated or other automated multiple entries will be accepted. Sponsor reserves the right to modify, extend, suspend, or terminate the Sweepstakes if it determines, in its sole discretion, that the Sweepstakes is technically impaired or corrupted or that fraud or technical problems, failures or malfunctions or other causes beyond Sponsor’s control have destroyed or severely undermined or to any degree impaired the integrity, administration, security, proper play and/or feasibility of the Sweepstakes as contemplated herein. In the event Sponsor is prevented from awarding prizes or continuing with the Sweepstakes as contemplated herein by any event beyond its control, Sponsor shall have the right to modify, suspend, or terminate the Sweepstakes. If the Sweepstakes is terminated before the designated end date, Sponsor will (if possible) select the First Prize winner and, if applicable, the Grand Prize winner, in a random drawing from all eligible, non-suspect entries as of the date of the event giving rise to the termination. Inclusion in such drawing shall be each entrant’s sole and exclusive remedy under such circumstances. These Official Rules cannot be modified or amended in any way except in a written document issued by a duly authorized representative of Sponsor. The invalidity or unenforceability of any provision of these Official Rules shall not affect the

validity or enforceability of any other provision. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these Official Rules shall otherwise remain in effect and shall be construed in accordance with their terms as if the invalid or illegal provision were not contained herein.

**GOVERNING LAW:** ALL ISSUES AND QUESTIONS CONCERNING THE CONSTRUCTION, VALIDITY, INTERPRETATION AND ENFORCEABILITY OF THESE OFFICIAL RULES OR THE RIGHTS AND OBLIGATIONS OF ENTRANTS OR SPONSOR IN CONNECTION WITH THE SWEEPSTAKES SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE INTERNAL LAWS OF THE STATE OF TEXAS WITHOUT GIVING EFFECT TO ANY CHOICE OF LAW OR CONFLICT OF LAW RULES OR PROVISIONS THAT WOULD CAUSE THE APPLICATION OF ANY OTHER STATE'S LAWS.
