

**VERIZON FIOS GAMERS SWEEPSTAKES
OFFICIAL RULES**

NO PURCHASE NECESSARY

PROMOTION DESCRIPTION: Verizon Fios Gamers Sweepstakes (the “**Promotion**”) begins on June, 16, 2022 at 12:00 a.m. Eastern Time (**ET**) and ends on August 1, 2022 at 11:59 p.m. ET (the “**Promotion Period**”). By participating in the Promotion, each entrant unconditionally accepts and agrees to comply with and be bound by these Official Rules and the decisions of Verizon Corporate Services Group Inc., located at 1 Verizon Way, Basking Ridge, NJ 07920 (“**Sponsor**”), Attn: Ryan Adler, which shall be final and binding in all respects.

ELIGIBILITY: Only legal United States residents of the state of New York and the city of Boston, Massachusetts who are twenty one (21) years of age or older are eligible to participate. Employees, officers, and directors of Sponsor, and of each of its respective, subsidiaries, affiliates, distributors, retailers, sales representatives, advertising and promotion agencies (collectively, the “**Promotion Entities**”), and the immediate family members, and/or those living in the same household of each such individual, are ineligible to participate in the Promotion or to win a prize. Promotion is void where prohibited by law.

HOW IT WORKS: Limit one (1) play per person and per email address per day. During the Promotion Period, eligible entrants will have the opportunity to win a variety of digital gift cards. Eligible entrants must complete a registration form including first and last name, a valid email address, a declaration of residence, and acceptance of these official rules in order to be eligible for this Promotion. After completion, instructions to play a virtual game will be presented. At the conclusion of the virtual game, you will be notified if you have won an Instant Prize (as defined below) and presented with instructions to claim the Instant Prize presented (subject to verification of eligibility). If you receive a message that contains any message other than an Instant Prize winner notification, you are not an Instant Prize winner. In addition, at the conclusion of each virtual game, every eligible entrant will earn one (1) entry into the grand prize drawing, up to a max of one (1) entry per day.

Except as contemplated in these Official Rules, personal information collected in connection with this Promotion will be used in accordance with Sponsor’s Privacy Policy (<https://www.verizon.com/about/privacy/>).

PRIZE WINNER DETERMINATION: Instant Prizes: A computer-generated winning time will be randomly generated for each Instant Prize available in this Promotion. The first eligible entrant to participate in and conclude the game at or after one of the randomly generated times will be deemed a potential winner of the Instant Prize indicated, subject to verification of eligibility. If you are a potential winner, you will be provided with instructions on how to claim your Instant Prize during your online session. If you receive a message that contains any message other than an Instant Prize winner notification, you are not an Instant Prize winner.

Grand Prizes: Each week during the Promotion Period, one (1) winner and two alternates will be selected by random drawing from all eligible entries that week to win a \$500 Verizon gift card.

During the Promotional Period, any non-winning eligible entry will be rolled over to the drawing for the following week. Each potential grand prize winner will have seventy-two (72) hours to respond after being contacted by email provided during the registration to play. In the event that a potential grand prize winner does not respond within the seventy-two (72) hour time frame, the next alternate will be contacted, and the seventy-two (72) hour clock will be restarted. In the event that the grand prize winner or either of the two alternates does not qualify or respond within the seventy-two-hour window, the prize will not be awarded.
