THE VERIZON FIOS HOLIDAY SWEEPSTAKES OFFICIAL RULES

NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.

The Verizon Fios Holiday Sweepstakes ("Sweepstakes") begins on November 18, 2022, at 12:00 a.m. Eastern Time (ET) and ends on December 9, 2022, at 11:59 p.m. ET (the "Sweepstakes Period"). By participating in the Sweepstakes, each entrant unconditionally accepts and agrees to comply with and be bound by these Official Rules and the decisions of Verizon Corporate Services Group Inc. ("Sponsor"), which are binding and final in all respects.

1. ELIGIBILITY.

The Sweepstakes is open to individuals who: (i) are at least 21 years of age at the time of entry in the Sweepstakes; (ii) are legal residents of New York and Philadelphia; and (iii) are NOT in one or more of the "Prohibited Persons" categories listed below. Any entry submitted by any ineligible person(s) will be void.

<u>Prohibited Persons</u>.
