

**THE VERIZON FIOS HOLIDAY SWEEPSTAKES
OFFICIAL RULES**

**NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.
VOID WHERE PROHIBITED.**

The Verizon Fios Holiday Sweepstakes (“Sweepstakes”) begins on November 18, 2022, at 12:00 a.m. Eastern Time (ET) and ends on December 9, 2022, at 11:59 p.m. ET (the “Sweepstakes Period”). By participating in the Sweepstakes, each entrant unconditionally accepts and agrees to comply with and be bound by these Official Rules and the decisions of Verizon Corporate Services Group Inc. (“Sponsor”), which are binding and final in all respects.

1. ELIGIBILITY.

The Sweepstakes is open to individuals who: (i) are at least 21 years of age at the time of entry in the Sweepstakes; (ii) are legal residents of New York and Philadelphia; and (iii) are NOT in one or more of the “Prohibited Persons” categories listed below. Any entry submitted by any ineligible person(s) will be void.

Prohibited Persons. The following individuals are not eligible to enter or win the Sweepstakes: (i) current and former employees (including, but not limited to, consultants, independent contractors, temporary employees, and interns) of Sponsor, CataBoom, (“Administrator”), and of their respective parents, subsidiaries, affiliates, authorized agents, retailers, sales representatives, distributors, suppliers, advertising agencies, promotion agencies (hereafter collectively, “Sweepstakes Entities”) and immediate family members of each such individual; and (ii) all individuals (including, but not limited to, consultants, independent contractors, temporary employees, former employees, and interns) who have, within the past six months, performed services for Sweepstakes Entities. “Immediate family” members include spouses, grandparents, parents, children and grandchildren, whether by marriage, past marriages, remarriage, adoption, cohabitation or other family extension.

2. HOW TO ENTER.

During the Sweepstakes Period, eligible entrants will have the opportunity to win a variety of digital gift cards. Eligible entrants must complete a registration form including first and last name, a valid email address, a declaration of residence, and acceptance of these Official Rules in order to be eligible for this Sweepstakes. After completion, instructions to play a virtual game will be presented. You must complete the virtual game in order to enter the Sweepstakes, however performance in the game does not affect your entry or odds of winning a prize in the Sweepstakes. At the conclusion of the virtual game, you will be notified if you have won an Instant Prize (as defined below) and presented with instructions to claim the Instant Prize presented, subject to verification of eligibility. If you receive a message that contains any message other than an Instant Prize winner notification, you are not an Instant Prize winner. In addition, at the conclusion of each virtual game, every eligible entrant will earn one (1) entry into the grand prize drawing, up to a max of one (1) entry per day. Entries must be received by 11:59:59 p.m. ET on March 30, 2022. Data usage rates may apply to access the Sweepstakes microsite.

3. CONDITIONS APPLICABLE TO ALL ENTRIES.

Limit one entry per person and email address per day during the Sweepstakes Period. Sponsor’s computer is the official time-keeping device for the Sweepstakes. All received entries become the exclusive property of Sponsor and will not be acknowledged or returned, and no correspondence will be entered into. Any attempt by an entrant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and/or logins, or any other methods will void that entrant’s entries and that entrant may be disqualified if discovered by Sponsor. The use of automated entry devices or any other conduct that impedes the integrity of the Sweepstakes is prohibited. Any individual who attempts to enter using false contact information or who uses any unauthorized device or artifice to enter using a false identity, as determined by Sponsor, will be disqualified. If there is a dispute

as to who submitted an entry, the entry will be deemed submitted by the Authorized Account Holder of the email address submitted at the time of entry. "Authorized Account Holder" is defined as the natural person assigned to an email address by an internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the email address in question. Sweepstakes Entities are not responsible for late, lost, incomplete, misdirected, stolen, or damaged entries or for technical, hardware, software or device malfunctions of any kind, lost or unavailable network connections, or failed, incorrect, incomplete, inaccurate, garbled or delayed electronic communications caused by the sender or by any of the equipment or programming associated with or utilized in the Sweepstakes that may limit the ability to participate, or by any human error that may occur in the processing of the entries in the Sweepstakes or other failures of any sort, fire, epidemic or pandemic, explosion, act of God, riot or civil disturbance, war, terrorist threat or activity, any federal, state or local government law, or any other cause not reasonably within Sweepstakes Entities' control. Sweepstakes Entities are not responsible for printing errors in these Official Rules. Entries may be rejected on the basis of abusive language or content that is deemed inappropriate by Sponsor in its sole discretion.

4. WINNER SELECTION

Instant Prizes: A computer-generated winning time will be randomly generated for each Instant Prize available in this Sweepstakes. The first eligible entrant to complete the virtual game at or after one of the randomly generated times will be an Instant Prize potential winner. If you are a potential winner, you will be provided with instructions on how to claim your Instant Prize during your online session. If you receive a message that contains any message other than an Instant Prize winner notification, you are not an Instant Prize winner.

Grand Prize Drawings. On or about [December 12, 2022], sixty (60) potential Grand Prize winners will be selected via random drawing by Sponsor or its designee, in Sponsor's sole discretion, from among all eligible Entries received during the Sweepstakes Period. Potential winners must meet all eligibility requirements and comply with these Official Rules to qualify for the prize. The judging organization's decisions are final on all matters relating to the drawing. Limit one prize per person during the Sweepstakes Period.

Termination. If Sponsor cancels, terminates, modifies, or suspends this Sweepstakes for any reason (including, without limitation, infection by computer virus, tampering, unauthorized intervention, fraud, technical failures, or any other cause beyond the reasonable control of Sponsor that corrupts or affects the administration, security, fairness, integrity or proper conduct of the Sweepstakes), Sponsor will select potential prize winners by random drawing from among all eligible, non-suspect entries received during the Sweepstakes Period prior to termination, or as otherwise deemed fair and appropriate by Sponsor in its sole discretion. 5. PRIZES / ODDS OF WINNING.

Grand Prizes. Each Grand Prize winner will receive a video-recorded personalized message from their choice of one of four celebrities, as indicated by the entrant on their entry form. **Approximate Retail Value ("ARV") of each Grand Prize is \$500.**

There are a total of 60 Grand Prizes to be won (Total ARV: \$30,000). By accepting a Grand Prize, the winner acknowledges and agrees that Grand Prize recordings will not be modified or altered in any way, or shared on any social media platforms.

Instant Prizes. Each Instant Prize winner will randomly receive one (1) \$50 virtual gift card from among the prizes below. **Approximate Retail Value ("ARV") of each Instant Prize is \$50.**

- One Hundred (100) \$50 Amazon gift card;
- One Hundred (100) \$50 Uber Eats gift card;
- One Hundred (100) \$50 Dunkin gift card;

- One Hundred (100) \$50 Verizon gift card;

There are a total of 400 Instant Prizes to be won (Total ARV: \$20,000).

All expenses and costs not expressly listed above, including, but not limited to, federal, state or local taxes on the value of the prize, are the sole responsibility of the winner. Prizes are not transferable, assignable, or redeemable for cash except at Sponsor's sole discretion. Prize details and availability are subject to change, in which case Sponsor may substitute a prize of equal or greater value. Any portion of prize not used by winner is forfeited and no cash substitute will be offered or permitted. Odds of Winning. The odds of winning depend upon the number of eligible entries received during the Sweepstakes Period.

6. WINNER NOTIFICATION PROCESS.

On or about [December 23, 2022], Sponsor will attempt to notify potential winners via email and/or phone, using information provided on the Entry form. Potential winners will be required to follow prize claim instructions provided and return all necessary prize claim documents within three (3) business days from the date of notification. Potential winners must complete and sign a Prize Acceptance & Liability Waiver and a Publicity Release before the Prize will be awarded (TN residents need not sign the Publicity Release). The Prize will be forfeited in the event that: (i) the potential winner is not in compliance with these Official Rules, including any eligibility requirements; (ii) the prize notification or attempted notification is returned as undeliverable; (iii) Sponsor does not receive timely response to prize notification; or (iv) a potential winner declines the Prize offered. If a prize is forfeited by a potential winner, Sponsor will select an alternate potential winner by applying the criteria set forth above.

7. GENERAL CONDITIONS.

By participating in the Sweepstakes, entrants agree to release, waive and hold harmless Sweepstakes Entities, and each of their respective affiliates, subsidiaries, parent corporations, retailers, sales representatives, distributors, and advertising and promotional agencies, and all of their officers, directors, shareholders, employees and agents, from all injuries, claims, damages, losses, costs or expenses of any kind (including, without limitation, attorneys' fees) resulting from the entrants' participation in this Sweepstakes, the entrants' acceptance, use or misuse of any prize or element thereof, (including any

ALL ISSUES AND QUESTIONS CONCERNING THE CONSTRUCTION, VALIDITY, INTERPRETATION AND ENFORCEABILITY OF THESE OFFICIAL RULES OR THE RIGHTS AND OBLIGATIONS OF ENTRANTS OR SPONSOR IN CONNECTION WITH THE CONTEST WILL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE INTERNAL LAWS OF THE STATE OF NEW JERSEY, USA WITHOUT GIVING EFFECT TO ANY CHOICE OF LAW OR CONFLICT OF LAW RULES OR PROVISIONS THAT WOULD CAUSE THE APPLICATION OF ANY OTHER STATE'S LAWS.

10. DISPUTE RESOLUTION.

Some jurisdictions do not allow for limitations on the ability to pursue class action remedies, or certain kinds of damages, and so these limitations may not apply to you.
