THE VERIZON FIOS HOLIDAY SWEEPSTAKES OFFICIAL RULES

The Verizon Fios Holiday Sweepstakes ("Sweepstakes") begins on November 9, 2023, at 12:00 a.m. Eastern Time (ET) and ends on December 10, 2023, at 11:59 p.m. ET (the "Sweepstakes Period"). By participating in the Sweepstakes, each entrant unconditionally accepts and agrees to comply with and be bound by these Official Rules and the decisions of Verizon Corporate Services Group Inc. ("Sponsor"), which are binding and final in all respects.

1. ELIGIBILITY.

The Sweepstakes is open to individuals who: (i) are at least 21 years of age at the time of entry in the Sweepstakes; (ii) are legal residents of Boston, MA, Baltimore, MD, Philadelphia, PA and Washington, D.C.; and (iii) are NOT in one or more of the "Prohibited Persons" categories listed below.
