

**WILD MIKE’S ULTIMATE PIZZA “SPIN TO WIN” PROMOTION
OFFICIAL RULES**

NO PURCHASE NECESSARY

PROMOTION DESCRIPTION: The Wild Mike’s Ultimate Pizza “Spin To Win” Promotion (the “**Promotion**”) begins on or about February 28, 2017 at 12:00:01 a.m. Eastern Time (“**ET**”) and ends on March 7, 2017 at 11:59:59 p.m. ET (the “**Promotion Period**”). Participation in the Promotion does not constitute participation in any other promotion, contest or sweepstakes. By participating in the Promotion, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Wild Mike’s Ultimate Pizza, 15815 SE Piazza Avenue, Clackamas, OR 97015 (“**Sponsor**”), which shall be final and binding in all respects.

ELIGIBILITY: Only legal United States residents who are eighteen (18) years of age or older are eligible to participate. Employees, officers and directors of Sponsor and each of their respective parents, subsidiaries, affiliates, distributors, retailers, sales representatives, advertising and promotion agencies (collectively, the “**Promotion Entities**”), and the immediate family members, and/or those living in the same household of each are not eligible to participate in the Promotion. Promotion is void where prohibited by law.

HOW IT WORKS: During the Promotion Period, eligible entrants will have the opportunity to instantly win prizes and enter to win the Grand Prize at the conclusion of the Promotion. Fans will be prompted to enter via the Sponsor home page and Sponsor social media posts. Eligible entrants must complete all instant win game instructions in order to be eligible for a prize in this Promotion. At the conclusion of the instant win game, you will be informed if you have won an Instant Win Prize in this Promotion (subject to verification of eligibility). If you receive a message that contains any message other than a winning prize message, you are not an instant win prize winner. All non-winning instant win game entries will be entered into the Grand Prize drawing. At the conclusion of the Promotion, one (1) Grand Prize winner will be randomly selected from all eligible entrants.

Eligible entrants may receive one (1) additional Grand Prize entry by sharing the Promotion entry link via designated social media platforms at the conclusion of the instant win game. Entrants will be required to follow the social media sharing prompts following the instant win game and will be required to post a promotional message on their social media feed to receive the additional entry. Limit one (1) additional entry per person and per email address for the Promotional Period.

Prize/Offer Winner Determination: One (1) computer generated winning time will be randomly generated for each Instant Win Prize available in this Promotion. If you are the first participant to participate at or after one of the randomly generated times, you will be a potential winner of the prize indicated, subject to verification of eligibility. If you are a potential winner, you will be provided with instructions on how to claim your prize during your online session. If you receive a message that contains any message other than a winning message, you are not a prize winner.

The Promotion Entities shall not be responsible for incorrect or inaccurate entry information whether caused by Internet users or by any of the equipment or programming associated with or utilized in the Promotion or by any technical or human error which may occur in the processing of the entries in the Promotion. The use of any device to automate the entry process is prohibited and will lead to disqualification.

In the event of a dispute over the identity of an entrant, entry will be deemed completed by the authorized account holder of the email address provided at time of registration. "Authorized account holder" is defined as the natural person who is assigned to an email address by an Internet access provider, on-line service provider, wireless carrier, or other organization (e.g., business, educational institution, etc.) that is responsible for assigning email addresses for the domain associated with the submitted email address.

PLAY/ENTRY LIMIT: One (1) entry per person and per email address per day for the Promotional Period.

The total value of all prizes is \$4,500. The odds of winning any prize are dependent upon the total number of entries received.

No mechanically reproduced, illegible, incomplete, forged, software-generated or other automated multiple entries will be accepted. Sponsor reserves the right to modify, extend, suspend, or terminate the Promotion if it determines, in its sole discretion, that the Promotion is technically impaired or corrupted or that fraud or technical problems, failures or malfunctions or other causes beyond Sponsor's control have destroyed or severely undermined or to any degree impaired the integrity, administration, security, proper play and/or feasibility of the Promotion as contemplated herein.
